


51 Primrose Rear inspection on May 6

The rear of this unit was walked with management and board member. The homeowner had installed new hardscape in the backyard. The neighbor is claiming that they have drywall cracks as a result of the backyard work. Please note that we did not have access to the neighbors unit to see the drywall cracks.

The owner had removed bricks or pavers and installed a new hardscape in the rear patio area. The hardscape was held back from the adjacent wall in question approximately 8-12". The sprinklers were capped off. The planter was below the adjacent weep screed. No visible cracks were noted in the stucco areas. As far as we can observe, the slab looked to be installed correctly and should not be an effect to the adjacent unit. If needed further investigation we recommend you consult with an engineer.
